Dear Resident, Family Member or Substitute Decision Maker:

It is that time of the year again.

Health, Seniors and Long-Term Care Public Health, Bethania and Pembina Place Mennonite Personal Care Home support and encourage Residents to participate in the Covid immunization program. please You will find the Covid Fact Sheet as an attachment to the email. It is our hope that you will support this initiative.

Starting May 1, 2026, individuals who received one dose of the COVID-19 vaccine since fall 2025 and who meet the following criteria may be eligible for an additional dose, provided at least three (3) months have passed since their most recent dose:

- Indigenous people 45 years of age and older, including First Nations, Inuit and Métis peoples, regardless of place of residence;
- **Adult residents of long-term care homes and other congregate living settings for seniors;**
- Individuals 6 months of age and older who are moderately to severely immunocompromised (due to an underlying condition or treatment).

The spring COVID-19 Immunization Program will run from May 1, 2026, to June 30, 2026.

Although you may have previously provided us with consent to administer the Covid vaccine, we are required to obtain informed consent annually.

You will be contacted by one of our Resident Care Managers this month. If you have any questions or require further information regarding Covid immunization, feel free to ask them when the Manager calls for consent.
